In preparing for our upcoming annual meeting and election, **June 9, 2024**, please familiarize yourself with the agenda items outlined in this letter. The meeting and voting will be held after our regular service on June 9th.

Many thanks to the Nominating Committee for developing the following slates of nominees for the church year 2024-2025. One nominee for the Nominating Committee to serve a one-year term, and two nominees for the Finance Committee to serve a three-year term.

#### Nominee for Vice President is Jiffy Shore:

<u>Biography:</u> Jennifer (Jiffy) Shore became a member of CVUU in 2020 yet was a previous member of UCN and former Teen advisor (2000-2007). She had a 13-year detour in Washington DC where she met and married her husband (Tom) and had baby Jackson (now almost 12 years old). She moved back to Norfolk during the pandemic and immediately re-signed the membership book. Since then, she has been on the nominating committee, the CREC, and the auction team. She is excited to join the CVUU Board as Vice President.

#### Nominee for Director is Tami Burke:

Biography: Little did I know when I passed by this building and saw it transform into CVUU that one day I would be standing inside. Originally from Maine, I now live in Norfolk, just a couple of miles from this spot. It feels natural to be here at the UU volunteering for Community Table and sharing my love of yoga with others. My life has always been a path with one thing leading to the next. From a career in public television, to marketing the craft brewing industry, to helping a leading ophthalmology practice grow, I've been fortunate to do what I love, and to share it all with my husband, Tracy. Being asked to join the board feels like a natural next step to get more involved and deepen my relationship with CVUU and the wonderful people Tracy and I are getting to know and call friends. Our CVUU Bylaws state: "Nominees for the Board of Directors must have been members of the congregation for at least one (1) year prior to the date of the yearly election meeting at which they are elected unless this restriction is waived by a two- thirds (2/3) vote of the congregation. All members of the Board of Directors must be members of the congregation in good standing." Tami Burke has been a devoted member of CVUU for 7 months at the time of this election, so we will need to approve her status as a nominee as well as approving her as a director. The CVUU Board of Directors asks the congregation to vote to waive the 1-year rule for Tami Burke as a Director as we also recommend her to the congregation as a new Director. A vote for Tami Burke is also a vote to waive the 5 months of membership she would need to have been her an entire year.

#### Nominee for <u>Director</u> is Kerry Kilburn:

<u>Biography:</u> Kerry Kilburn is a retired ODU biology professor and martial arts instructor. A Chesapeake resident since 1995, she has been a CVUU member for three years. She has volunteered with CVUU's Sandwich Makers, Community Table, Religious Education, and Coffee Makers. In her spare time, she enjoys photography, reading, and weaving.

#### Nominee for the Finance Committee is Annelies Brock:

**Biography:** Annelies Brock lives in Norfolk and has been attending CVUU with her daughter, Marilyn, since January 2023. She currently teaches OWL for grades 7-9, sings in the choir, and is a member of CUUPS. Outside of CVUU, she works as an attorney in the Office of the U.S. Trade Representative in Washington, DC. She enjoys writing, photography, and hermeticism, among other things.

#### Nominee for the <u>Finance Committee</u> is Julia Lawrence:

**Biography:** Julia is a retired accountant with a passion for financial stewardship and brings experience and dedication to the table. Throughout her career, she honed her skills in budgeting, forecasting, and financial planning. Her discerning eye for detail ensures that every choice made is well-informed and in the best interest of the organizations she was a part of. #### CVIC Homeschoolers seeks status as a CVUU Affiliate Group

7.5 Affiliated Groups: The Board shall adopt a policy whereby voluntary organizations that have at least one (1) member of the church and that support the stated mission of the church may be recognized as affiliated groups and receive the rights and responsibilities associated with this status as defined in the policy. The granting or revoking of affiliated group status shall require a recommendation by the board and approval by the congregation at an annual or special meeting.

CVIC Homeschoolers (Coastal Virginia Inclusive Co-op), created and led by CVUU members Stacia Sanders and Naomh O'Connell, seek status as a CVUU Affiliate Group. The Board has finalized their recommendation and now seeks approval by the congregation per bylaws for Affiliated Groups. CVIC has been formally incorporated and obtained non-profit status. Their vision, mission, and goals are aligned with the Article II Values of Unitarian Universalism.
